Vide paper read as (1) above, an application for affiliation of a M.Ed Course was received from the Manager, New B.Ed College, Nellimoodu, Thiruvananthapuram for the academic year 2008-09.

Vide paper read as (2) above, the National Council for Teacher Education granted conditional recognition to the New B.Ed College, Nellimoodu, Thiruvananthapuram for the conduct of the M.Ed Degree Course of one year duration with an annual intake of 25 (twenty five) students from the year 2008-09 with the stricture that admissions should not be made until unconditional letter of recognition is issued by Southern Regional Committee, NCTE.

Vide paper read as (3) above, the Syndicate considered the application for affiliation of M.Ed Course in New B.Ed College, Nellimoodu, Thiruvananthapuram for the academic year 2008-09 and resolved to constitute an Inspection Commission to assess the facilities available in the College for the grant of affiliation to the Course.

Vide paper read as (4) above, the Hon'ble High Court of Kerala directed the University that a decision should be taken on the request for affiliation to start M.Ed Degree Course within four weeks from the date of receipt of the Judgement.

Vide paper read as (5) above, the Syndicate considered the matter in the light of the Judgement of the Honble High Court and in the light of the report of the inspection. Commission and resolved to sanction Provisional Affiliation to M.Ed Degree Course in the New B.Ed College. Nellimoodu.

Thiruvananthapuram for the academic year 2008-09 with an annual intake of 25 seats.

Vide paper read as (6) above, the Manager, New B.Ed College, Nellimoodu, Thiruvananthapuram was directed to fulfill the remaining procedural formalities and to submit the compliance report to the effect that all the deficiencies pointed out by the Inspection Commission would be rectified before the commencement of the Course in the New B.Ed College, Nellimoodu, Thiruvananthapuram for the academic year 2008-09.

Vide paper read as (7) above, the Manager, New B.Ed College, Nellimoodu, Thiruvananthapuram remitted the prescribed fees and submitted the compliance report for starting the M.Ed Degree Course for the academic year 2008-09.

Sanction has therefore been accorded for the grant of Provisional Affiliation to the M.Ed Degree Course with an annual intake of 25 students in the New B.Ed College, Nellimoodu, Thiruvananthapuram for the academic year 2008-09 subject to;

- (1) Fulfillment of the conditions prescribed by the Inspection Commission as approved by the Syndicate.
- (2) Obtaining of concurrence from the Government for the Course, and
- (3) Condition that admission shall be made only after getting the unconditional letter of recognition from the Southern Regional Committee, NCTE
